III. Scope of Data Processing

The purpose of processing your data is your membership in the HSHL Grad Net of Hamm-Lippstadt University of Applied Sciences to maintain contact after your de-registration. With our HSHL Grad Net, we, as your former university, would like to maintain communication and exchange with you regarding your personal and professional further education and development. Furthermore, we would like to inform you about news from the university and about opportunities to exchange and network with other alumni. In addition, the HSHL Grad Net offers free services for its members (e.g. career service consulting, university sports, discounts on offers from the Academy for Academic Advanced Training).

IV. Legal Basis of Data Processing

The processing of all your voluntarily provided information and your registration for HSHL Grad Net via the online form on our website and by e-mail is based on Art. 6 (1), a) GDPR.

V. Recipients of the Personal Data

Access to your data is only granted to the Career and Alumni Services team, Center for Teaching Management at Hamm-Lippstadt University of Applied Sciences. Beyond this, your data will not be passed on to third parties unless we are obliged to do so due to official or court orders or you have consented to the transfer.

VI. Duration of Storage

Your data will be processed until you unsubscribe from HSHL Grad Net or until you withdraw your consent or object, unless there is another legal basis for the processing for a longer period (e.g. storage). Your data will then be deleted in order to comply with the principle of data minimization.



VII. Rights of the Data Subject

As a data subject, you can assert the rights granted to you by the GDPR at any time; these are

- The right of access by the data subject if personal data are being processed in accordance with the Art. 15 GDPR;
- The right to rectification or completion of data concerning the data subject in accordance with the Art. 16 GDPR;
- Right to erasure of the data concerning the data subject in accordance with the Art. 17 GDPR;
- The right to restriction of processing of the data in accordance with Art. 18 GDPR; des Art. 18 DS-GVO:
- The right to data portability of the data concerning the data subject in accordance with the Art. 20 GDPR;

Right to Object

You have the right to object, on grounds relating to your particular situation, at any time to processing of personal data, provided that the data processing is based on your consent or on our legitimate interests or those of a third party. In that case, we will no longer process your data unless we can demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms or the processing is necessary for the establishment, exercise or defense of legal claims. If we process your data for direct marketing purposes, you can object to the processing at any time (Art. 21 GDPR).

VIII. Right of Withdrawal

If you have consented to the processing of your data by Hamm-Lippstadt University of Applied Sciences, you may revoke your consent at any time with effect for the future. Hamm-Lippstadt University of Applied Sciences will then delete your data immediately. The legality of the data processing carried out on the basis of the consent until the revocation is not affected by the revocation.
