1. Regulation Governing Amendments to the Rules of Procedure of the Senate of Hamm-Lippstadt University of Applied Sciences dated June 22, 2020

Based on Sections 2(4) and 22 of the Act on the Higher Education Institutions of the State of North Rhine-Westphalia (Higher Education Act – HG) dated July 12, 2019 (GV. NW (Law and Ordinance Gazette of the Land North Rhine-Westphalia) p. 377), in conjunction with Sections 4, 9(7) of the Constitution of Hamm-Lippstadt University of Applied Sciences dated June 22, 2015 in the version amended on January 13, 2020, the Senate has decided to amend the rules of procedure as follows:

Article 1:

- 1) Section 6(5) Sentence 4 will be stricken. Consequently, Section 6(5) of the rules of procedure reads as follows:

A petition is deemed accepted when the majority of members present who have voting rights approve. In the event of a tied vote, the petition shall be deemed rejected. Abstentions and invalid votes shall not be counted towards the majority.

Article 2:

- 1) These amendment regulations enter into force after their publication in the Official Notices of Hamm-Lippstadt University of Applied Sciences.
- 2) It should be noted that pursuant to Section 12(5) of the Act on the Higher Education Institutions of the State of North Rhine-Westphalia (Higher Education Act – HG NRW) any claims arising from a breach of procedural or formal requirements of the regulatory or other autonomous law of the university can no longer be asserted after one year has passed since this announcement was published, unless
 - a) the regulations have not been properly published,
 - b) the Presidential Committee had previously raised an objection to the resolution of the body that decreed the regulation, or
 - c) the formal or procedural deficiency was reported to the university beforehand indicating the violated legal provision and the fact giving rise to deficiency.
